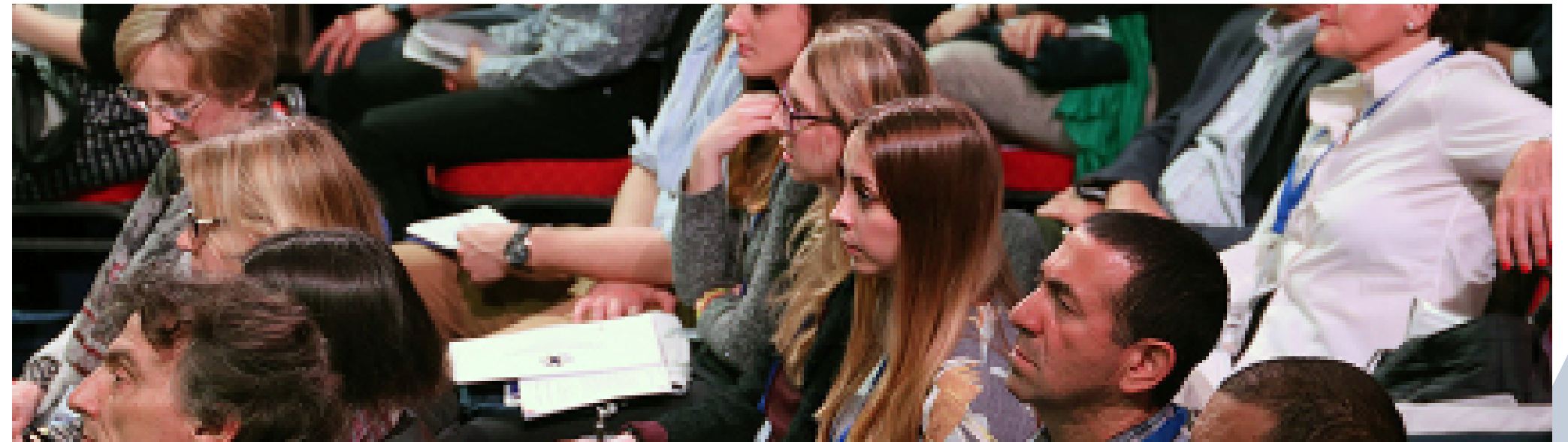

OUR PROGRAMS

The Center for Cultural Diplomacy Studies offers educational and academic programs in partnership with leading universities, enabling students to explore, analyze and experience cultural diplomacy both in theory and in practice. The CCDS focuses on exploring the balancing between hard and soft power, global governance, the process of globalization in an interdependent world, international economics & business, multiculturalism, intercultural dialogue & exchange, human rights, and religion. We research the ability for culturally based initiatives to further mutual understanding and in turn to foster global peace and stability.

The programs offer high levels of leadership and provide students with the skills to shape their future leadership roles while addressing critical issues challenging the world today. The programs provide advanced knowledge and analytical tools for the study and practice of cultural diplomacy and address the potential that it has in shaping international policies and global strategies.



CERTIFICATE PROGRAMS

The Center for Cultural Diplomacy Studies developed the Certificate Programs in Cultural Diplomacy in order to offer and provide participants with comprehensive, tailored learning opportunities in a number of related fields. Each program features lectures, seminars and workshops lead by experts from the fields of international politics, diplomacy, academia, civil society, and the private sector.

Certificate Programs offer the opportunity to learn about the innovative field of Cultural Diplomacy over a short period of time, allowing students and professionals with other commitments to participate. The programs offer access to high profile guest lectures, audio-visual content, a large library of reading materials, and professional networking opportunities to promote one's own projects. All participants will be awarded an official certificate of attendance upon completion of the program, which will provide details of the speakers who took part and the topics discussed. The professional development programs of the CCDS are actively supported by major figures in international politics, academia, the diplomatic community, civil society, and the private sector.



ICD Academy Sessions are week-long programs that explore the role of cultural diplomacy in contemporary international relations. Each program features lectures, seminars and workshops led by experts from the fields of international politics, diplomacy, academia, civil society, and the private sector. During their time in Berlin participants will also have the opportunity to take part in cultural and social activities and to visit institutions such as the German Foreign Office, the German Parliament, the Berlin City Hall, cultural institutions and Berlin-based embassies.

WEEKLONG SEMINARS

The ICD Academy was established to allow individuals of all academic and professional backgrounds the opportunity to learn more about the subject of cultural diplomacy. The Academy Session timetables are designed to allow participants the opportunity to discuss salient issues with experts from the field, whilst providing a framework for group discussions amongst each other. E-LEARNING PROGRAMS

The Center for Cultural Diplomacy Studies has developed the E-Learning Programs in order to offer individuals interested in the field of Cultural Diplomacy and related areas the opportunity to increase their experience in this expanding field.

The E-Learning Programs have been designed to be studied at a distance, giving students the flexibility to study from any location in the world within a structured and supportive framework. The programs are built in a way that allows individuals currently working full time the ability to acquire academic knowledge with maximum flexibility regarding scheduling and learning formats. The programs have been designed in a flexible way to allow students to structure their instruction around their own schedules.

The courses will be delivered via an e-Learning platform, designed to help participants meet the course's learning objectives through a self-paced study routine supported by multimedia, required and optional readings, and a wealth of other information adapted specifically to full-time professionals.

The programs offer access to high profile lecturers, audio-visual content, a library of reading materials, and professional networking opportunities to promote one's own projects. Students will have access to innovative research and publications in the field and a distinguished and renowned faculty. In addition to obtaining an expertise in Cultural Diplomacy, students will have the possibility to create and implement their own programs of Cultural Diplomacy with the support of the ICD and its partners.

“What’s up America: Perspectives on the United States and Transatlantic Relations” was an event held by the Institute for Cultural Diplomacy in association with the Federal Agency for Civic Education. The event brought together key stakeholders from the US, Europe, and across the world to reflect on the future of the US inner and foreign policies, with a particular focus on the transatlantic relationship. The series of events on that topic consisted of lectures, panel discussions, and debates featuring renowned experts from international politics, journalism, and academia.

Through the history, the United States of America was a model country for the West, it seemed to the whole world. Today, however, the critical voices piled up, even in their own country. With this event held in Berlin, the ICD and Federal Agency for Civic Education shed light on both sides of the image of America, in the same time taking a look at the ongoing fascination that the state still exercises and analyzing current issues and external perspectives with experts. Namely, a country that already embraced diversity in the founding motto (“E Pluribus Unum – Out of Many, One”) and sometimes confuses it can only be understood through an interdisciplinary approach.

For this reason, the What’s up America? Dealt with aspects of culture, society, economics and politics in order to gradually assemble these individual areas into a diverse overall picture of America and to critically reflect its perception in Europe. To meet this requirement, among others the event hosted remarkable journalist Charles Lane who delivered a broader picture of the US society in the last quarter of the 20th century that has an undeniable influence on the current policies, both on the national and international level.

In light of the forthcoming US presidential elections, this event recognized two significant developments in the field of international relations. Firstly, the global deterioration of international relations and secondly, the emergence of new global challenges such as populism, fake news era, climate change and the prevention of health pandemics, which are all areas of activity that require the transatlantic partnership to build sustainable and multilateral approaches. In recognition of these developments, there is a demonstrable need to analyze and reflect on the activity of the US and Europe within this new context and in addressing these new challenges.

Escape and Islam as mobilizing topics of Right wing populism

(Berlin; 6th July 2016)

The moderation was done by Nina Amin, a journalist of the RBB radio. The debate was led by the invited guests, Karin Prieste, a historian and political scientist with expertise in right wing extremism, Stefanie Beck, the consultant of extremism prevention of the Central Agency of Political Education of Baden-Württemberg and finally by the Berlin journalist with Moroccan roots Mohamed Amjahid, who is thematically specialized on xenophobia and the stereotypes against refugees.

Taking a glance at the historical background of Germany, the discussion began with the question, whether Germany experiences a revival of right-wing populism. Considering the happenings of the New Years' Eve night in Cologne and the uprising popularity of the AfD, it is high time to confront this question and raise awareness. In fact, for a long time Germany was immune against right-wing populism. However, nowadays we experience an immense shift to the right. The journalist Mr. Amjahid spoke about the media coverage in Germany and its influence on people's perception and their attitudes towards refugees. Furthermore, the role of the social media has been discussed, since people start to distribute their individual, subjective opinions. This often leads to non-academic discussions, fake news, virtually invented realities and thus tremendous hatred. Mr. Amjahid appeals to the audience that all of us shall focus on factual based, objective discussions.

In particular the following questions were raised: Who are the populists? Why do people vote for this AfD? What is the issue about Islam? In a very critical way radical minority within this religion were mentioned. Furthermore, one has to mention that the Islam is not just a religion but also represents a society with respected rules. All that has to be considered when discussing this topic.

Concluding words were formulated by Mr. Amjahid, as he was discussing the term populism and the need to differentiate more between certain terms and what meaning they encompass.

Throughout the years of 2015-16 we have seen the number of migrants flooding into Europe gain momentum as the pace and magnitude of the migration has been sharply rising. Although recent movement of refugees both from Syria and elsewhere has gained momentum, when looking for the trigger, it is essential to go back to 2011 when the Arab uprising began in the Middle East.

The Syrian regime managed to remain intact until the beginning of March 2011 when civil war eventually broke out as a result of mass protests from the population, which followed the same style as those which had previously taken place in both Tunisia and Egypt. Due to these significant recent events the Arab world can be considered to be currently in a phase of major transitions.

The Arab World has a rich diversity of ethnic and religious communities, which includes a population of over 400 million Arabs. The Arab world's ancient civilization, which goes back over 2000 years has offered significant cultural, scientific, mathematic, scholarly and other contributions to global civilization. The Arab world today is keeping up and in some areas, is excelling with development of the digital era and its societies are some of the fastest developing and growing in the world.

The International Symposium on Cultural Diplomacy in the Arab World focused on the opportunities for cultural diplomacy in the Arab World in the framework of the current transitions and challenges. 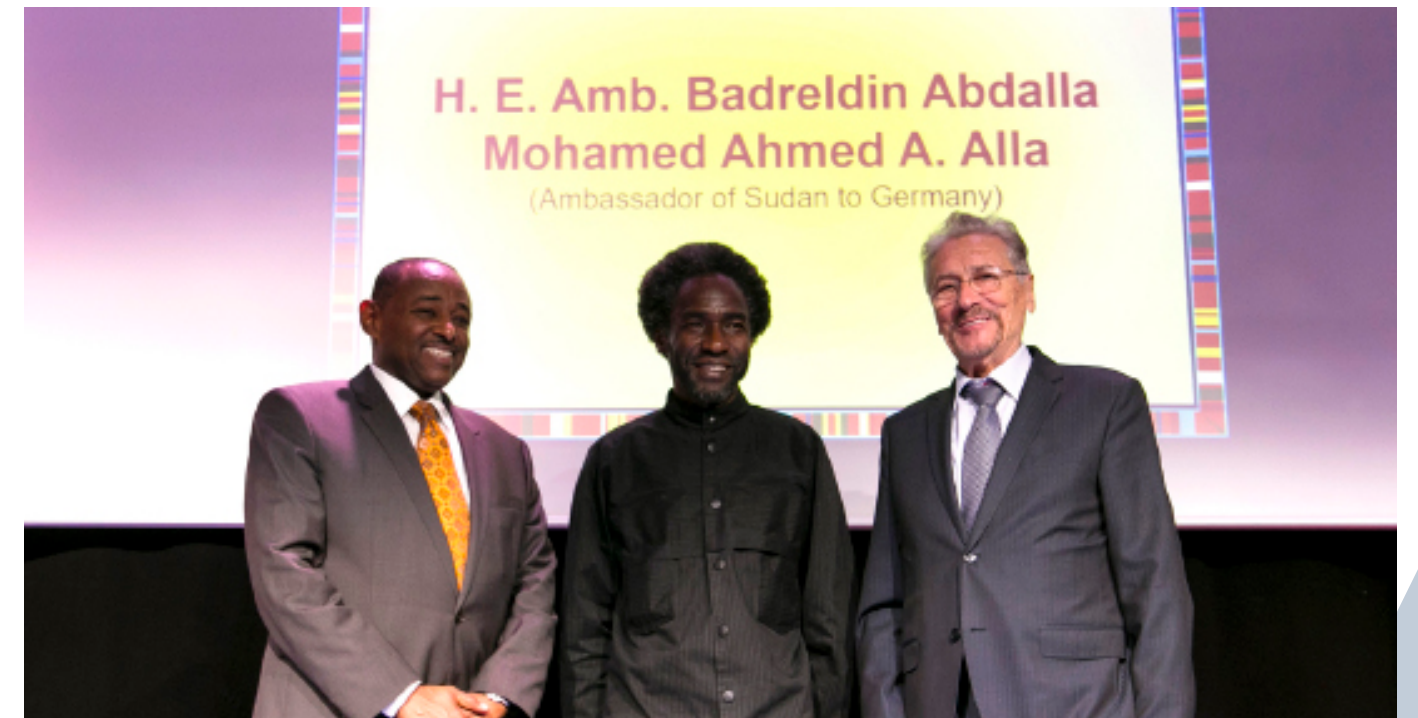

The Reykjavik Roundtable on Human Rights 2016

“Democratic Accountability, State Sovereignty, and International Governance”
(Reykjavik; April 27th–29th, 2016)

The Reykjavik Roundtable on Human Rights 2016 reviewed the current state of global Human Rights compliance and enforcement. At the Roundtable, prominent individuals from international courts, politics and academia, discussed the role of international institutions, states, and non-state actors in preventing and halting human rights abuses.

The event emphasized on four themes:

- 1) The potential for reform of international institutions as part of a global rights agenda.
- 2) The tension between geopolitical interests and the institutionalization of the Responsibility to Protect (R2P) doctrine;
- 3) The interplay between international governance, state prerogatives, and non-state involvement in human rights protection.
- 4) The role of trade unions, NGOs and the responsibility of transnational corporations for human and labor rights violations.

Based in Reykjavik, Iceland, the conference was hosted at the Official Residence of the President of Iceland, the Parliament of Iceland, the National Heritage Building of Iceland, the Government Reception House, and the Höfði House.

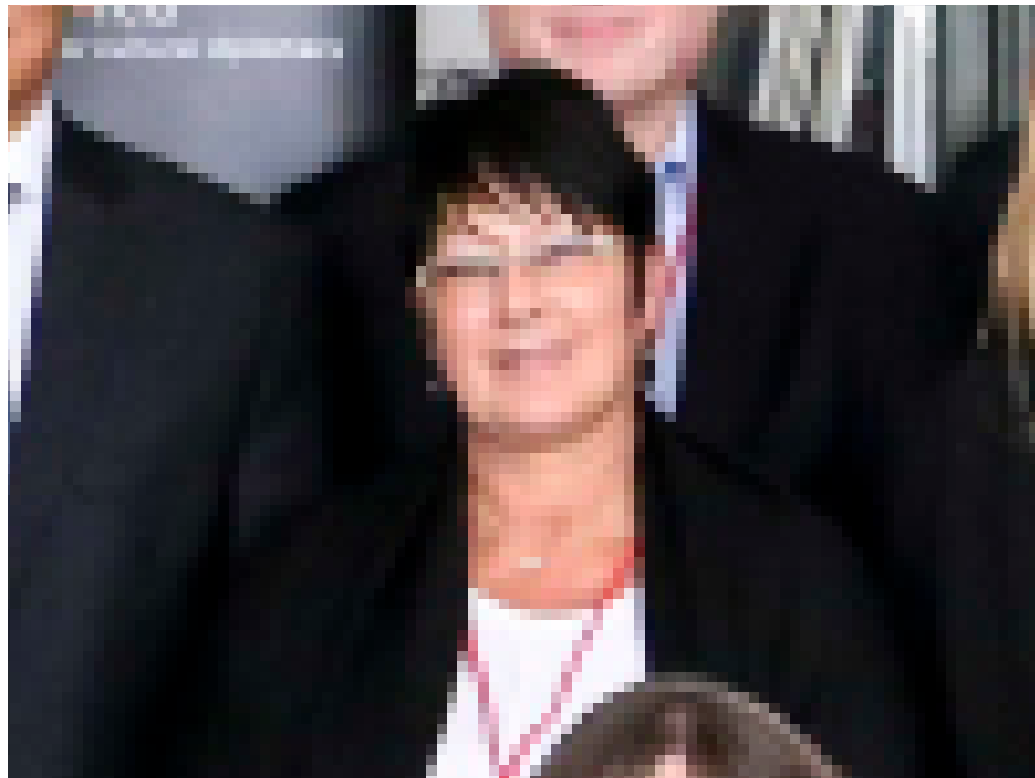

THE IPAHP VIOLENCE PREVENTION PROJECT

(Initiative on the UN Genocide Convention)

Growing academically-based research demonstrates and supports the claims that the use of all forms of violence, whether it be in the form of armed conflicts, international crime, the abuse of women and children, to verbal violence are all on the rise. The **IPAHP** is deeply concerned from this growing global use of violence in recent years and therefore has initiated the **IPAHP Violence Prevention Project**.

The IPAHP is dedicated to tackling issues of violence and to initiate ongoing activities, which will include a diverse group of programs, in order to work together with decision makers, NGOs and private sectors in order to reduce the outspread use of violence around the globe at the local, national and international levels.

The IPAHP is particularly concerned with issues of political and religious conflicts and has developed specific programs to tackle these kinds of conflicts.



THE IPAHP “BORN EQUAL PROJECT” PROJECT

(Initiative on the UN Women’s Rights Convention; The Work Place Initiative; Initiative for Multiculturalism)

The preamble of the **United Nations Charter** outlines the principle of human equality that has long been recognized by people across the world, but which is all too frequently forgotten and disregarded. Despite the commitment of UN member states to promote equality, discrimination based on gender, race, national origin, cultural background, age, or sexual orientation, as well as other forms of discrimination, remain prevalent across the world. It is in recognition of this inequality that the IPAHP has established the “Born Equal” project.

“Born Equal” is initiative project of the **IPAHP** that aims not only to raise awareness of discrimination, but also to support a diverse range of activity that promotes equality at different levels, in different regions of the world. The initiative is fully interactive and its goal is to bring together academics, politicians, diplomats, journalists, private sector representatives, civil society practitioners, students and other stakeholders, in support of this cause.

THE IPAHP CORPORATE CULTURAL DIPLOMACY PROJECT

(Initiative on the “UN Global Compact”)

Multinational corporations have carved a significant public role in twenty-first-century daily life of us all. As this role becomes more and more prominent, private entities have capitalized on the opportunities presented by Corporate Social Responsibility (CSR) programs. These programs are dedicated to activities that ensure the company is operating in a responsible way toward its local, national and global environments.

CSR is a key facilitator of cultural diplomacy, helping to building dialogue, understanding and trust between companies and their clients (and potential clients) all over the world through for example grants, exchange programs and sponsored community initiatives. The stronger the relationships between a company and its surrounding communities, the more trust will grow, and the easier it will be to foster both consumer activity and general goodwill toward a corporation.

Corporate cultural diplomacy helps present a more accurate and comprehensive picture of particular corporate environments and the ethical standards a company subscribes to. By initiating campaigns to counter misconceptions regarding its activities, a company can increase its credibility and legitimacy while simultaneously heightening its local, national and global profiles. This strategy can go a long way toward mitigating potential conflicts.

The IPAHP has designed the Corporate Cultural Diplomacy Project in order to draw attention to and further debate about the importance of these diplomatic efforts of the private sector for both corporates and communities.



THE IPAHP INITIATIVE ON ENVIRONMENTAL RESPONSIBILITY & CLIMATE CHANGE

According to the UN Millennium Development Goals, environmental sustainability has become a priority in guarantying a safe future for following generations. Climate change is significantly affecting many aspects of modern live and increasing poverty conditions in developing countries. Therefore, immediate solutions for a sustainable planet are necessary in working towards global stability.

When considering environmental issues, long-term national interests should converge towards the common goal of creating a sustainable society and unanimously agreed-upon action must be taken.

Successful initiatives at a national level often involve the participation of civil society institutions, such as environmental NGOs, lobbies, and legal firms. These groups are capable of shaping cultural habits and public opinion in favor of a more sustainable approach towards a wide range of issues leading to concrete political and legal outcomes.

The **IPAHP** recognizes the vital role that civil society plays in the realm of environmental policy-making, and calls for increased cooperation of these groups at an international level. Furthermore, we believe an interdisciplinary and holistic approach on this issue is necessary as sustainable development entails different areas of actions, particularly environment, economy, and social affairs.

The **IPAHP** has therefore initiated the **Environmental Responsibility & Climate Change Initiative** in order to draw attention, explore, discuss, and promote issues concerning environmental responsibility and climate change challenges with the aim to develop proposed solutions. The initiative will also focus on the importance of building and supporting dialogue between science and civil society in order to raise awareness and provide viable solutions through domestic and international policy considerations.

To date, environmental summits such as the Rio +20 and the Doha Climate Change Conference have revealed how urgent it is to achieve collective action between international political actors in order to take on these challenges.



THE IPAHP GLOBAL HEALTH SECURITY PROJECT

(The Responsibility to Care Initiative)

The IPAHP Global Health Security Project aims to raise awareness of potential threats to Global Health and to facilitate a global dialogue on ways to improve the Global Health infrastructure.

According to Article 25 of the Universal Declaration of Human Rights, “Everyone has the right to a standard of living adequate for the health and well-being of himself and of his family, including food, clothing, housing and medical care and necessary social services.” From its very conception, the Universal Declaration of Human Rights has emphasized that a functioning health and social service infrastructure is fundamental for achieving an adequate standard of living and well-being of the individual.

However, the majority of citizens throughout the world still do not have access to adequate medical care and social services. The lack of sufficient facilities and health programs only serves to exacerbate an already tenuous situation worldwide, something which has been showcased by the 2014 outbreak of the Ebola virus in Western Africa and its inherent danger of it turning into a global pandemic.

The Global Health Security Project was also conceived as a means to influence decision-makers of the world to contribute to the improvement of the current „Global Health Threat Response“ infrastructure. This project aims not only to raise awareness on global health issues, but also to draw attention on related initiatives and activities. The IPAHP seeks to issue a call for governmental responsibility and to promote a joint effort from institutions and civil society.

THE SOUND OF FREEDOM PROJECT

In an age of liberal democracy, freedom of expression is a linchpin within society. The concept of a democracy indicates the ability to formulate ideas, make decisions and participate openly within the political, social and economic sphere. Since 1689 and the English Bill of Rights, freedom of expression has been considered an important issue and is often regarded as a natural right for all human beings.

Included in the 1949 United Declaration of Human Rights and the European Convention on Human Rights Article 10, freedom of expression should be a prominent issue within all societies and yet in 2011 alone the world has experienced several uprisings as a consequence of oppression and censorship.



THE ORGANIZATION FOR YOUTH EDUCATION & DEVELOPMENT (OYED)

The Organization for Youth Education & Development (OYED) operates under the legal framework of the Institute for Cultural Diplomacy and is organized in cooperation with national governments. The ICD Youth Education & Development Program is dedicated to the creation, promotion and execution of youth-oriented education and development programs. Over the past decade, the program has managed to bring thousands of young people together from every corner of the world to discuss and promote issues that are vital to the younger generation, and has grown to become one of Europe's largest independent cultural exchange organizations, whose programs facilitate interaction between individuals of all backgrounds from across the world.

The **ICD** understands that in a rapidly evolving and globalized world, the rights and opportunities of young people around the world are neglected far too often. As a result, both the success of these young individuals and the success of their respective countries can be unnecessarily limited. The **ICD** believes that the youth are the future and supporting the world's young people is both an urgent and global priority. Since its inception, the ICD has dedicated itself to the promotion and empowerment of young leadership initiatives in order to impact the next generation of global leaders worldwide.

The program provides the younger generation with greater access to personal development, while increasing their chances for professional opportunities. The major objectives of the program are to promote and empower the world's young people through the application of cultural diplomacy initiatives at the local, national and international levels. **The program serves as a platform to promote and sustain intercultural dialogue at all levels and by doing so promotes specific educational and professional opportunities for youth.**



HUMAN RIGHTS & GLOBAL PEACE

In light of the importance of these issues and the urgent current global challenges, the IPAHP has established its Peace-building Program in order to contribute to achieving sustainable solutions and strategies for securing global peace and reconciliation. **The IPAHP Peace-Building Project** is a continuation of a 5-year long project, the “World without Walls Project”, which has been implemented between 2009 and 2014. But the new project will be a 10-year long project, which started in 2015. It is conducted by the ICD in partnership with global governance organizations, national governments, leading academic institutions and multinational corporations.

This project is designed to serve as an influential peace-building actor with a specific focus on conflict resolution and reconciliation. It will be comprised of annual meetings and events, peace delegations, extensive research in the field and activities for the youth. Special emphasis will be given to develop multiple follow up initiatives by other global actors, dialogue with key decision makers and engagement of those with financial means who can support the development of such initiatives.



INTERNATIONAL CONFERENCES & EVENTS

The OYED organizes and hosts events around the world at both the very high-level (including Heads of State, Ministers and Members of Parliament) and at the grass-roots level working with local communities and schools. The intention of the events is firstly to raise awareness and promote the issues that lie at the core of the OYED, secondly to expand the network of partners and youth of the OYED, and thirdly to further promote the mission of the OYED, so that it is implemented increasingly at the local, national and global levels.

OYED YOUNG LEADERS' FORUMS

Through its **Young Leaders Forums**, the **OYED** is empowering the next generation of young leaders from around the world by creating exchange programs, events, programs and follow-up projects between them.

By working with the next generation of leaders, the OYED and its partners have a unique opportunity to empower youth and have a long-term impact on the future global leadership.

THE ICD VOLUNTARY INTERNSHIP PROJECT (2008-17)

The **ICD Voluntary Internship Project (2008-17)** is a 10 year program with the main purpose to enable students who need an internship as a compulsory part of their BA or graduate studies to engage in cultural diplomacy and in doing so, to further promote cultural diplomacy and multiculturalism worldwide.

The positioning of the **ICD** in the center of Europe, makes it a natural hub for the younger generation and indeed, the past years of the project have been witness to interns being active participants in the multicultural field, where lasting friendships were formed and valuable contacts made, which immediately expanded each individual's network to all parts of the world.

The diverse multicultural environment provides an excellent framework for Cultural Diplomacy to be practiced on a daily basis within the office as well as outside of the office. One of the main privileges afforded by the project is to work in a young, interdisciplinary and international environment, which serves as a model of successful multiculturalism in practice. The experience of learning to work together in a multicultural and international organizational environment is a rare, unique and a rewarding common experience.

INTERNSHIP PROJECT

The **OYED Internship Project**, which has now existed for ten years, was officially launched in January 2008 and has been successful in achieving its main purpose of enabling like-minded students and young professionals to come to Berlin and engage in intercultural and international programs. The internship program is an ongoing, evolving project and, as such its ultimate goal is to enable and empower young professionals to engage in intercultural relations and in so doing promote multiculturalism worldwide.

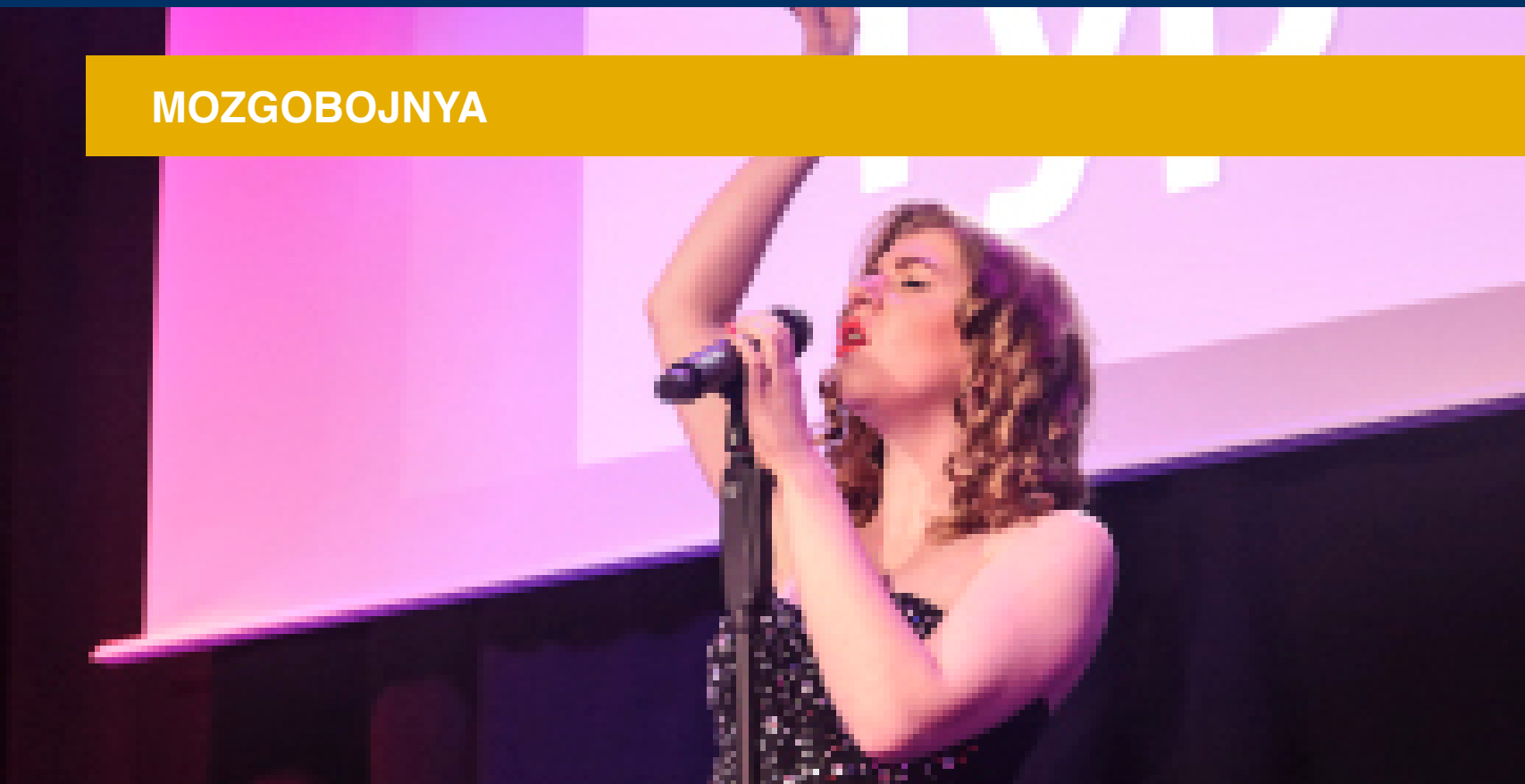
